Parent's Protocol

Dear Parents and Carers,

This letter is to set out the arrangements we have made for Kids Kapers Holiday School. These are in line with recent government guidance.

We ask **YOU** to adhere to the following protocol to ensure all staff and children remain safe and well whilst in our care.

We will be:

- Asking that **ANYONE** who displays Corona virus symptom, or who lives with someone who does, **NOT** to attend the setting.
- Keeping our children in small groups of 15 with as much consistent staffing as possible and minimising contact with other groups within the setting.
- Cleaning our hands more often than usual. We have put routines to ensure children understand when and how to wash their hands and washing for at least 20 seconds using water and soap and dry them thoroughly or use alcohol hand rub or sanitiser.
- Ensuring children understand good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach.
- Putting in place an enhanced cleaning schedule, ensuring surfaces touched by children and staff are cleaned regularly and throughout the day. This will include tables, door handles, restrooms and play equipment.
- Providing **FULL PPE** for our staff.
- Be prioritising bookings to **CRITICAL KEY WORKERS** and **VULNERABLE CHILDREN**.

We ask **YOU**:

- On arrival and pick up to physically distance from each other and staff, and to limit drop off and collection to **ONE** parent/carer per household.
- That children **ARE NOT** to bring toys, blankets or other items from home to the setting, unless this is essential to their health and wellbeing. These will be refused on arrival.
- That children **ARE NOT** to bring **ANY** form of electronic device into the setting. These will be refused on arrival.
- To **PLEASE** apply your child/children's sun cream before arriving at setting
- That if your child/children or anyone within your household has corona virus symptoms, they **SHOULD NOT** attend the setting under **ANY** circumstances and isolate in accordance to the government guidelines. Once tested negative via corona virus swab test your child/children may return to setting.

UPTON SETTING – it is required by the premises provider that ALL children's temperature WILL be taken and recorded before entering premises.

By signing this disclaimer, you are agreeing to abide by each of the above points. Anyone who does not sign or abide, your child/children will not be permitted into the setting.

This is to ensure safety of all staff and children.
